Guidelines for Authors

It is a multidisciplinary, peer reviewed periodical that broadcast and present unique, viable, original & impactful' ideas, technology, design and innovations accomplishments in India and all around the globe, providing the knowledge platform leadership needed in taking decisive steps towards innovation excellence in agriculture domain.

CCS NIAM welcomes articles representing original research in the field of agriculture and allied activities on thrust areas like Organic Farming, Precision Farming, Agricultural Supply Chain, Agricultural Biotechnology, Post-Harvest & Food Technology, Food Processing, IoT, ICT and AI in Agriculture, Natural Resource Management, Animal Husbandry, Dairying, Agri-Input tools and technologies, Farm Mechanisation, Agriculture Engineering, Animal Husbandry and Dairy, Agri-Input Tools and Technologies, Agri Extension Education, Waste to Wealth, Secondary Agriculture, Agri Clinics & Farm Health services.

Submission of Manuscript: Articles may be submitted in Word format (.doc or .docx files) by email to nabi.jas@ccsniam.ac.in The Editorial team will correspond with the main author. The following points may please be addressed in the covering letter:

1. The central focus of your article;
2. What is new about your concept / idea?
3. Can your idea / concept be applied and How?

Preparation of Manuscript

Manuscript may be within 5000 words excluding tables, figures and references. Manuscripts may be prepared in the following order:

- Title page;
- Abstract;
- Keywords;
- Main text;
- Acknowledgements;
- References

- Font Times Roman 12, A4

The title page would include the title of the article, name/s of the author/s, their institutional affiliation/s, postal addresses, contact numbers and email addresses. One author should be identified as the corresponding author. The email address of the corresponding author will normally be displayed in the article. Each article should be accompanied with a declaration by all the authors that:

1. They are authors of the article in the order in which listed;
2. The article is original, has not been published and has not been submitted for publication elsewhere.

Abstract: The first page of the article should have an abstract of the article in 200-250 words preceding the main text. The abstract should be informative and state the scope of the work, methodology and principal findings.

Keywords: 4-6 keywords may be included Authors are requested to organize their articles, into the following sections as far as possible:

- (I) Introduction, Background
- (II) Objectives
- (III) Methodology
- (IV) Results and Discussion,
- (V) Policy Implications and Conclusion.

On receipt of your article, CCSNIAM will acknowledge receipt. After that, the article will be reviewed internally and then sent out for blind peer review.

Review: All papers submitted to Journal of Agri-Business Innovations & Startups are subject to a masked peer review. The criteria for acceptance of articles in the Journal are topicality, originality of the idea, unique argument or insight; clarity of objectives, sound methodology, clear and logical analysis and depth of discussion, appropriate examples, consistent structure and presentation, fairly good English and contribution to knowledge. The Editor reserves the privilege of editing the manuscript, returning it to the author for revision or rejecting any manuscript as unsuitable in topic, style or form with or without requesting external review.

If the author wishes to see the edited copy he/she should make this request at the time of sending the article, If more than 500 words/a table/figure have been quoted from a published work in the article, the authors may enclose a copy of permission obtained from the respective copyright holder. It is the author's responsibility to obtain permission in writing for the use of previously published material and authors are responsible for payment of any permission fee.

Copyright: The author owns the copyright of the article until the article is accepted for publication. After the communication of acceptance, the copyright of the article is owned by CCS NIAM and should not be reproduced elsewhere without the written permission of the editor and the authors of the article.

Spellings: British spellings may be used.

Numbers: Please use figures to express all numbers 10 and above. Words may be used to express numbers lower than 10, and numbers that begin a sentence/title.

Abbreviations: A term to be abbreviated must be written out completely the first time followed immediately by its abbreviation in parentheses. Thereafter, the abbreviation may be used.

Quotations: Citation of less than 40 words may be incorporated in the text within double quotes. Quotations of 40 words or more should be indented from the text, giving the source of the quotation (author's last name, year and page number/s in parenthesis).

Tables and Figures: Tables and figures may be indicated by number (see Table 1), not by placement (see Table below). All figures and tables should be cited in the text.

Citation of Sources: When paraphrasing or referring to an idea contained in another work, the author must cite the source in the text. The surname of the author and the year of publication may be inserted at the appropriate point in the text as part of the narrative or in parentheses.

References

- The list of references at the end of the article should provide complete information to identify and retrieve each source: Author/s, year of publication, title and publishing data. All references cited in the text should be listed alphabetically by surname of the first author and presented in full at the end of the article. Conversely each entry in the reference list must be cited in the text. The reference to other each entry in the reference list must be cited in the text. The reference to other works should be provided in the text using citations written in the author-date method, e.g., (Singh, 2015).
- Please include references within the last ten years' period.
- When a reference has more than one author, please list all the authors' name. For an institutional report, full name of the institute may be written as the author. For a government report, the author is the name of the country/state and the name of the Ministry/Department, separated by a colon.
- When ordering more than one reference by the same author, the earlier publication may be listed before the later publication. References by the same author with the same publication year may be arranged alphabetically by the title, and suffix a, b, c and so on added to the year.
- A website article may be cited as: Author's last name, initials. (year, month, date of publication, Article title, Retrieved (date) from (URL)).
- A book may be cited as: Author/s last name, initials (year of publication). Title of the book. Place of publication and name of the publisher, separated by a colon.
- An article in an edited book may be cited as: Author's last name, initials. (year of publication), Title of the article in Initials and surname of editors, (Ed./s), title of the book, (pp. pages). Place of publication and name of the publisher, separated by a colon.
- An article published in a journal may be cited as: Author's last name, initials, (year of publication). Title of the article, Name of the journal, volume (issue), page numbers.

The first author will receive on publication, one copy of the journal.

Declaration to be submitted by Authors.
